Previous Board/Board Committee Actions:

On October 18, 2016, staff was given direction by the Board of Supervisors to develop language that reflected Board direction. In the afternoon reconvening of the item, then Chief Planner Andy Gustavson presented to the Board what was entitled the "not-withstanding" clause. The elements which this language would cover were discussed in the morning session and then discussed and clarified during the afternoon session that day. Staff was directed to formalize the language incorporating the specific changes discussed into the two draft

ordinances listed above and to then move forward with the environmental analysis with the two documents, as amended by staff. This was done and the environmental analysis proceeded with those changes.
