**Summary of Request:**

Public Health, Prevention and Planning Unit (PAPU) will apply to receive a 21 month grant of \$52,500 from CDPH, Safe and Active Communities Branch to sustain the work of the Safe Rx Mendocino Opioid Abuse Prevention Coalition. The grant will provide \$7,500 for the first 3 months (FY 16/17), \$30,000 for the following 12 months (FY 17/18), and \$15,000 for the remaining 6 months (FY 18/19). Grant dollars will be used to increase Naloxone access in the County, improve safe prescribing practices, and conduct a public education and media outreach campaign, all focused on decreasing deaths and overdoses due to the misuse and abuse of Opioids.
