Summary of Request:

Mendocino County Department of Transportation will prepare and administer construction plans, specifications, estimates and contract documents for DOT Contract No. 160089, Hearst Willits Road Culvert Replacement on Hearst Willits Road. This project replaces an existing culvert that has deteriorated to the point of needing to be replaced and requires the design to provide for unimpeded fish passage of salmonids. DOT Contract No. 160089 is being funded with County Road funds for an estimated amount of \$193,000. A temporary road closure for a period not to exceed two weeks will be needed for construction.
