Previous Board/Board Committee Actions:

On December 7, 1999, the Board of Supervisors approved Agreement No. 99-263 creating an executive automobile allowance for appointed Department Heads, and extended by Resolution to elected and exempt Department Heads and approved County executives. On June 5, 2007, the Board amended agreement No. 99-263 by adopting Resolution No. 07-100 and Agreement No. 07-100 and Agreement No. 07-100A.

Summary of Request:

As provided in BOS Agreement No. 99-263, the following classifications/positions are eligible for an automobile allowance upon application to, and written approval from, the acting or appointed County Executive Officer, or designee, and acceptance by the Board of Supervisors: a) an assistant department head, who is an exempt bargaining unit employee, at the request of the appointing authority department head; b)
