Approval of Amendment to Memorandum of Understanding (Board of Supervisors Agreement No. 17-048) Between the County of Mendocino and Lake County for Acting Sealer Services in the Amount of \$1,500 Per Month, Extending the Term of the Agreement from August 31, 2017 to October 31, 2017

Recommended Action/Motion:

Approve amendment to Memorandum of Understanding (Board of Supervisors Agreement no. 17-048) between the County of Mendocino and Lake County for Acting Sealer services in the amount of \$1,500 per month, extending the term of the Agreement from August 31, 2017 to October 31, 2017; and authorize Chair to sign same.

Previous Board/Board Committee Actions:

On July 11, 2017, the Board of Supervisors approved a Memorandum of Understanding between Mendocino and Lake Counties, Board of Supervisors Agreement no. 17-048, for Acting Sealer services in the amount of \$1,500 per month, for the term of July 1, 2107 through August 31, 2017.

Summary of Request:

Business and Professions Code (PBC) Section 12200 requires that counties appoint a Sealer of Weights and Measures. Mendocino County's Sealer position became vacant at the end of January 2017. In the absence of a licensed Sealer, the Board of Supervisors approved an MOU between Mendocino and Lake Counties

authorizing Sealer services to be provided by Lake County. The proposed amendment would extend the term of the agreement from August 31, 2017 to October 31, 2017.

Alternative Action/Motion:

Do not approve the amendment to the MOU, and request a new list of licensed Sealers from the Secretary of the California Department of Food and Agriculture, or allow the Secretary to appoint a Sealer of their choosing.
