### **Summary of Request:**

On October 9, 2017 the Governor declared a state of emergency for eight counties due to wildfires and on October 10, 2017 the President declared a major disaster (FEMA-4344-DR) making federal disaster aid available to the same eight counties, including Mendocino County for the 2017 California Wildfires.

A Cal OES 130 Designation of Applicant's Agent Resolution for Non-State Agencies Form is required in order for the County to be eligible to receive State and/or Federal funding. The attached resolution is a specific resolution and effective only for disaster number FEMA4344-DR. By adopting the resolution, the County designates the individuals who hold the specific titles of Chief Executive Officer/Director of Emergency Services, Recovery Director, and Recovery Finance Director to be the County's representatives to FEMA and Cal OES.
