In October 2017, the Mendocino County Superior Court appointed Robert Ochs as the Interim Chief Probation

Officer and Human Resources entered into an agreement with Chief Ochs to provide consultation and training services, and to act as the Chief Probation Officer until such time as a permanent Chief Probation Officer is hired.

A new Chief Probation Officer has been appointed and Mr. Ochs will continue his role as acting Chief Probation Officer until the new chief is sworn in by the Mendocino County Superior Court on February 23, 2018. This amendment will cover the additional hours required until that time.
