After budget hearings held on June 6 and June 7, 2017, the Board of Supervisors adopted the FY 2017-18 Mendocino County Budget.

<u>Summary of Request:</u>

Since FY 2016-17, the Board of Supervisors has adopted a budget in June, prior to the previous year's books being closed. This budget was based on end of the fiscal year projections, rather than actual numbers. The Second Quarter Report includes a brief update on local economic indicators, updates from departments on budget benchmarks through the second quarter of the fiscal year (July 1 through December 31) and updates on
