Summary of Request:

Crestwood Behavioral Health, Inc., provides secure residential treatment programs that deliver a broad range of services for adults requiring a structured environment due to mental health challenges. Levels of care include the provision of groups, trainings, and programs to promote the recovery of clients for independent living in the community. The County's goal is to transfer clients to a less restrictive residential setting as soon as they are medically able. Basic daily rates vary depending on the level of care. Behavioral Health and Recovery Services referred more clients than anticipated during the 2017-18 fiscal year. The increase to the Agreement will pay for an increased number of clients.
