Agreement provides for the staffing of full facilitation and/or co-facilitation of six, two-hour FEGs for up to fifty weeks in Ukiah, Willits, and Laytonville and covers costs associated with facilitation, travel, documentation, participation in Child and Family Team meetings, Case Conferences, and other reporting needs as required by Family and Children's Services social workers.
