Summary of Request:

Mendocino County Health and Human Services Agency, California Work Opportunity and Responsibility to Kids (CalWORKs) Job Services (CJS) has been partnering with, and co-located with, Employment

Development Department (EDD) since 1996. This contract will allow EDD staff to be available to provide direct placement and/or individualized job development services in order to support CJS participants who are transitioning to self-sufficiency. EDD services for CJS participants include assessment of employment goals and assistance with expanding job searches by linking transferrable skills to broader occupational and industrial categories.
