Summary of Request:

The use of peer support for behavioral health has existed for decades and has become more popular in recent years. Peer support has been shown to improve quality of life, improve engagement and satisfaction with services, improve whole health, decrease hospitalization and reduce overall cost of services. Health and

Human Services Agency, Behavioral Health and Recovery Services is contracting with National Alliance on Mental Illness (NAMI) Mendocino to provide Prevention and Early Intervention Services using the peer support model as part of the Mental Health Services Act three-year plan. These services support the community and build protective factors that reduce negative outcomes related to mental illness. Services include outreach to individuals suffering from first break of mental illness and other symptoms of mental illness, support for family members and educational groups open to the general public.
