Adoption of Resolution Amending Mendocino County's Conflict of Interest Code by Adding and Amending Articles I - VI and Amending Appendices A and B

Recommended Action/Motion:

Adopt Resolution amending Mendocino County's Conflict of Interest Code by adding and amending Articles I - VI and Amending Appendices A and B; and authorize the Chair to sign same.

Previous Board/Board Committee Actions:

October 19, 2010: Board of Supervisors adopted Resolution No. 10-173. March 26, 2013: Board of Supervisors adopted Resolution No. 13-028.

<u>Summary of Request:</u>

It is requested that the Board of Supervisors adopt the proposed Resolution amending the current Conflict of Interest Code by adding and amending Articles I - VI. The Political Reform Act of 1974 (Government Code § 87306.5) requires every local government agency to review its Conflict of Interest Code biennially, in evennumbered years, no later than October 1st. The Conflict of Interest Code has not been updated in over a decade other than to add positions. The purpose of the proposed amendments to the Conflict of Interest Code is to give greater clarity and direction to assist employees in avoiding a conflict of interest. Also, there have been substantial changes in positions over recent years. The Board has added and/or eliminated the following designated positions listed in Appendix A, Part I, and has added 3 Municipal Advisory Councils resulting in the need to amend and correct the County's Conflict of Interest Code.
