#### **Summary of Request:**

Government Code section 26909(c)(1) allows a special district to have an annual review performed, rather than a yearly audit, providing the district's annual revenues do not exceed one hundred fifty thousand dollars (\$150,000) and the district's board unanimously requests the annual review. The Auditor-Controller confirms that the district's revenues are less than one hundred fifty thousand dollars (\$150,000).
