Redwood Quality Management Company (RQMC) has been arranging specialty mental health services to

Children and Youth, age 24 years and younger, on behalf of Mendocino County since 2013 when the County began contracting for mental health services instead of providing mandated mental health services directly. RQMC, functioning as an Administrative Services Organization (ASO), oversees and manages the delivery of these services as delineated in the Mental Health Plan (MHP) controlled by the State Department of Health Care Services. The proposed 2018-19 contract with RQMC continues the ASO model and allows RQMC to arrange and pay for specialty mental health services aimed at assisting children and youth with severe emotional disorders. This, in turn, allows the County to maintain a comprehensive MHP and comply with applicable laws, rules and regulations.
