### **Summary of Request:**

Redwood Community Crisis Center (RC3) provides emergency mental health crisis intervention services to the children, youth, and young adults in Mendocino County who are experiencing crisis episodes and need

immediate support. RC3 will provide one Community Liaison and three Regional Support Team Members to provide monitoring for youth experiencing First Episode Psychosis, with 24/7 crisis response, outreach and engagement, after care services, and will work closely with other community organizations.
