Summary of Request:

Pacific Gas and Electric Company (PG&E) has announced its intention to sell the Potter Valley Project (PVP) and to request proposals from interested parties beginning in early December, 2018. The Inland Water and Power Commission (IWPC), of which Mendocino County is a member agency, has entered into a non-disclosure agreement with PG&E in order to review confidential information related to the PVP. IWPC has contracted for legal services to assist with data analysis, identification and review of strategies for acquisition, preparation of a formal proposal and negotiation with PG&E. The initial cost to perform the tasks that have been identified is capped at a not to exceed amount of one hundred thousand dollars (\$100,000) of which Mendocino County's proportionate share would be one-fifth, or a not to exceed amount of twenty-thousand dollars (\$20,000).
