Summary of Request:

The Air Quality Management District is requesting to enter into a Legal Services Agreement with Christiana Darlington for Separate Legal Representation through June 30, 2019. Ms. Darlington has over ten years' experience in air quality law, CEQA and planning. She is currently contracted with several other air quality management districts and was recommended by the Air Pollution Control Officers of those districts to assist the District in matters related to District programs and mandated requirements. The District is also requesting approval of the transfer of funds from the District's Fund Balance in the Amount of \$20,000 to increase the District's Legal Fees Budget Appropriation to Cover the Unanticipated Expenses Related to the District's Request for Separate Legal Representation.
