Each year, the Board approves the Airport Capital Improvement Plans (ACIP) for Little River Airport and Round Valley Airport.

### Summary of Request:

Each year, the Federal Aviation Administration (FAA) asks local airport sponsors to update their ACIP for each

airport for the next five years, outlining proposed capital improvement projects to be funded through the Airport Improvement Program. The ACIPs for Fiscal Years 2019 - 2024 are now due to be submitted to FAA. Mendocino County Department of Transportation recommends the Board approve the attached proposed ACIP for each airport and authorize the Director of Transportation to sign on behalf of the County for all pertinent documents required for filing the ACIPs with the FAA.
