Summary of Request:

The Mendocino County Jail issued a Request for Proposal in 2013, RFP# 18-13. An agreement with Integrated Security Controls, Inc. was awarded. The contractor provided the purchase of and installation of software, door controls, intercoms and an IP Video system for jail security. Subsequent contracts have been entered into with the contractor since 2013 for regular maintenance of the security systems and replacement parts when

necessary. This current agreement renews the regular maintenance services for staff and inmate safety and also includes software updates, inspections, testing of equipment, warranty work on servers and cameras, emergency services and phone support, scheduled camera replacements and consulting services for security electronics project designs and conformity to established County jail standards to maintain safety for both staff and inmates.
