Summary of Request:

Unwanted vehicles are frequently disposed on public right of way shoulders and private property without authorization. County funds are used to abate through clean-up and hauling. Even where a Vehicle Identification Number can identify the owner of record, our District Attorney is unable to adequately punish the party responsible for the dumping. We should not tolerate scrap vehicle litter. The existing violation is only an infraction and has proven to be an insufficient deterrent. Maximum penalty should be six months in jail or a
