#### **Recommended Action/Motion:**

Adopt resolution approving Department of Transportation Agreement Number 220003 with Geo-Logic Associates, in the amount of \$605,763 for the term beginning upon execution of the Agreement through July 31, 2027, for landfill monitoring and reporting services, and authorizing the Director of Transportation to sign any and all amendments to the Agreement not exceeding \$60,576 (Gualala, Caspar, Laytonville Areas); and authorize Chair to sign same.

### **Previous Board/Board Committee Actions:**

By Resolution Number (No.) 09-076 (April 7, 2009) the Board of Supervisors (BOS) approved Department of Transportation (DOT) Agreement No. 090054/BOS Agreement No. 09-051 with Geo-Logic Associates for

Water Quality Monitoring Report Preparation for Caspar, South Coast, and Laytonville Landfills. By Resolution No. 12-020 (January 24, 2012) the BOS approved DOT Agreement No. 110106/BOS Agreement No. 12-014, Professional Services Agreement with SHN Consulting Engineers & Geologists, Inc., (SHN) for Water and Gas Monitoring Services at Closed Landfills Located in Laytonville, Caspar, and Gualala. By Resolution Number (No.) 17-074 (June 6, 2017), the BOS approved DOT Agreement No. 170015/BOS Agreement No. 17-037 with SHN Consulting Engineers & Geologists, Inc. for Engineering and Consulting Services for the Landfill Water and Gas Monitoring and Reporting Program.

### **Summary of Request:**

DOT Agreement No. 220003 provides for professional civil engineering, geotechnical and environmental services for landfill monitoring and reporting at Mendocino County's three inactive/closed landfills for a period of five years. Landfill monitoring and reporting is mandated by orders from the North Coast Water Quality Control Board and professional consulting services are needed to assist County staff and ensure compliance with requirements. A Request for Proposals was issued on March 21, 2022, to which two technical proposals were received from firms capable of providing the necessary services. DOT has determined Geo-Logic Associates is the firm best qualified to perform the work under DOT Agreement No. 220003. After discussions and negotiations, Geo-Logic Associates has agreed to perform the services under DOT Agreement No. 220003 for a not-to-exceed amount of \$605,763. DOT requests and recommends the BOS approve and award DOT Agreement No. 220003 to Geo-Logic Associates to perform engineering and consulting services for Landfill Monitoring and Reporting. DOT also believes it is prudent to authorize the Director of Transportation to approve amendments to DOT Agreement No. 220003 up to \$60,576 to address unanticipated work due to adjustments to the requirements of the monitoring and reporting program.
