Summary of Request:

The Mental Health Services Act (MHSA) provides funding for the Community Services and Supports (CSS)

Outreach and Engagement component program, and the Prevention and Early Intervention (PEI) Prevention services component program. CSS programs connect individuals with serious mental illness to the appropriate mental health support programs. PEI programs work with communities to mitigate the risk of development of mental health conditions by strengthening protective factors. Action Network provides services in the south coast region of Mendocino County and supports culturally specific treatment options, including therapeutic counseling, referrals, and connection to mental health services. Services outlined in this contract are part of the array of services in the Mental Health Services Act Three Year Program and Expenditure Report.

This contract is a continuation of the previous agreement 21-149 that expired on June 30, 2022. To avoid a gap in services, we are requesting this contract be backdated to match the effective agreement date of July 1, 2022.
