The County has utilized OpenGov's online Management Reporting & Transparency software since 2017 to provide the public with the ability to access County financial information. The software includes essential visualizations and customized reporting features that are beneficial to the public. The proposed amendment incorporates a new quote from OpenGov that will allow the County continued use of the software through July 16, 2025, at the rate of \$15,000 per year. This rate remains unchanged from the original agreement executed in 2019.
