#### **Previous Board/Board Committee Actions:**

By Resolution No. 12-054 (March 27, 2012) Board approved BOS Agreement No. 12-034/DOT Agreement No. 110118 with GHD Inc., for the replacement of the Mill Creek Bridge on Hill Road. By Resolution No. 15-092 (June 16, 2015) Board approved Amendment No. 3 for additional soil sampling and footing design.

## **Summary of Request:**

The California Department of Transportation has required some additional analysis and design changes that caused revisions to numerous environmental documents, right-of-way acquisition areas, and additional staff time to make the revisions. GHD has agreed to perform this work for an additional \$157,727.
