Approval of Retroactive Agreement with Mendocino County Fire Safe Council for Fire Safe Council Operational Services in the Amount of \$100,000, Effective July 1, 2020 to June 30, 2021

#### **Recommended Action/Motion:**

Approve retroactive agreement with Mendocino County Fire Safe Council for Fire Safe Council Operational Services in the amount of \$100,000 effective July 1, 2020 to June 30, 2021, and authorize Chair to sign same.

#### **Previous Board/Board Committee Actions:**

The Board approved a funding of \$100,000 to Mendocino County Fire Safe Council at the Fiscal Year 2020-21 Proposed Budget Hearings.

#### **Summary of Request:**

The Board approved a funding of \$100,000 at the Fiscal Year 2020-21 Proposed Budget Hearings to fund Mendocino County Fire Safe Council's (MCFSC) operational costs for fiscal year 2020-21. This funding request is to accommodate increased demand in MCFSC services and create a long-term strategy to be fiscally independent. Activities under this contract include improving organizational functions, educating residents, and pursuing funding for fire preparedness projects.

This contract is retroactive as the final budget was finalized and adopted on June 23, 2020; therefore, necessitating the agreement to be presented at a future Board meeting for consideration.
