Adoption of Resolution Approving Department of Transportation Agreement Number 200041, with Wood Rodgers, Inc., in the Amount of \$762,353, for Professional Engineering Design Services, and Authorizing an Additional Contingency Amount of \$76,300, for the Outlet Creek Bridge Replacement on Reynolds Highway, County Road 310, Milepost 4.87 (Willits Area)

**Recommended Action/Motion:**

Adopt Resolution approving Department of Transportation Agreement Number 200041, with Wood Rodgers, Inc., in the amount of \$762,353, for professional engineering design services and authorizing an additional contingency amount of \$76,300, for the Outlet Creek Bridge Replacement on Reynolds Highway, County Road 310, Milepost 4.87 (Willits Area); and authorize Chair to sign same.

**Summary of Request:**

Department of Transportation (DOT) Agreement Number (No.) 200041 provides for preliminary engineering and design work, including environmental studies, plans, specifications, and estimate, needed for the Outlet Creek Bridge Replacement on Reynolds Highway. Wood Rodgers has agreed to perform the required work for a not-to-exceed amount of \$762,353. Costs of the project are to be funded primarily through the Federal Highway Administration (FHWA) Highway Bridge Program (HBP), with the local match covered through Toll Credits. Future amendments for additional work will be determined based on supplemental funding from FHWA. DOT believes it is prudent to begin work with the existing funds from FHWA Allocation No. 1 in the amount of \$446,300, followed by Allocation No. 2, in the amount of \$316,053 upon receiving confirmation of the additional grant funding. DOT also believes it would be expedient to request a 10% contingency in the amount of \$76,300, in order to facilitate timely completion of the work.
