#### Summary of Request:

Redwood Toxicology Laboratory provides all drug/alcohol testing devices, and all specimen testing, for individuals who are required to drug test for Family and Children's Services, either as part of investigations regarding child abuse or neglect, or as part of a client's case plan to determine if drugs and/or alcohol are being used.

Redwood Toxicology Laboratory, one of the nation's largest drug and alcohol testing laboratories, is the government services division of Alere Toxicology. They are able to provide rapid and reliable results which impacts social worker and court decisions about children's safety in homes with parents who are testing positive for drugs or alcohol.
