Health and Human Services Agency, Employment and Family Assistance Services is contracting with National Training Consultants to create the curriculum for, and facilitate, two workshops: *World of Work* job retention workshops in Ukiah and Willits; and *Building Confidence* job skills workshops in Ukiah. These unique workshops specifically aim to assist and motivate CalWORKs participants to seek employment opportunities, prepare for the workforce, and make skilled decisions which lead to employment and employment retention. National Training Consultants will also assist CalWORKs Job Services staff with trainings, development and evaluation of the CalWORKs program, and case conferencing for clients' progress.
