# **Previous Board/Board Committee Actions:**

On December 19, 2017, January 9, 2018 and January 23, 2018, the Mendocino County Board of Supervisors provided direction to staff to review certain aspects of the Cannabis Cultivation and Facilities Ordinances and report back to the Board with proposed amendments.
