Adopt Resolution approving Amendment Number 5 to Board of Supervisors Agreement Number 12-034/Department of Transportation Agreement Number 110118, with GHD Inc., in the amount of \$85,336 for additional professional engineering design services to extend the termination date to December 31, 2021, for the Mill Creek Bridge Replacement on Hill Road, County Road 327B, Milepost 2.05 (Covelo Area); and authorize Chair to sign same.

Summary of Request:

Amendment No. 5 provides for \$85,336 in additional funds needed to complete further environmental studies, and geotechnical engineering services including revisions to structural engineering designs as required by the California Department of Transportation. The costs of replacement of this bridge are anticipated to be paid for by the Federal Highway Administration (FHWA) Highway Bridge Program (HBP) and Toll Credits.
