Request for an Administrative Coastal Development Permit to construct a new 1,605 square foot single-family residence, with 588 square foot deck, 529 square foot garage, 120 square foot shed, 2,500 square foot driveway, and 443-square-foot second residence, and connect to water and sewer district. The project was administratively approved by the Coastal Permit Administrator (CPA) on June 14, 2022 and requires the Board of Supervisors authorization for issuance of the permit.
