**SECOND AMENDMENT TO COUNTY OF MENDOCINO
AGREEMENT NO. BOS-25-131**

This second Amendment to Agreement No. BOS-25-131 is entered into by and between the **COUNTY OF MENDOCINO**, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and **ST. HELENA HOSPITAL DBA ADVENTIST HEALTH ST. HELENA AND DBA ADVENTIST HEALTH VALLEJO**, hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. BOS-25-131 was entered into on July 29, 2025 (the "Initial Agreement"); and

WHEREAS, First Amendment to Agreement No. BOS-25-131 was entered into on December 16, 2025 (the "First Amendment"); and

WHEREAS, the Initial Agreement and First Amendment are referred to as the Agreement; and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this second Amendment will become part of the Agreement and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to increase the total amount payable by \$1,500,000 from \$1,000,000 to \$2,500,000.


NOW, THEREFORE, we agree as follows:

1. The total contracted amount set out in the Agreement is hereby increased by \$1,500,000 from \$1,000,000 to \$2,500,000.

All other terms and conditions of the Agreement shall remain in full force and effect.
