

**RESOLUTION NO. 26-091**

**RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING DEPARTMENT OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 260010 TO PERFORM THE 2026 CORRECTIVE/PREVENTATIVE MAINTENANCE PROJECT ON VARIOUS COUNTY MAINTAINED ROADS, AT AN ESTIMATED COST OF \$3,000,000 (CASPAR AREA)**

WHEREAS, the Mendocino County Department of Transportation (DOT) is desirous of providing road maintenance by applying a Chip Seal or a Chip Seal with a Full Depth Reclamation on the following sections of County Roads:

- a. Caspar Road, County Road (CR) 569, Milepost (M.P.) 0.00 to M.P. 0.78,
- b. Caspar Street, CR 410E, M.P. 0.00 to M.P. 0.23,
- c. Fern Creek Road, CR 411A, M.P. 0.00 to M.P. 0.97,
- d. Caspar Little Lake Road, CR 409, M.P. 0.00 to M.P. 3.30,
- e. Caspar Orchard Road, CR 410, M.P. 0.00 to M.P. 0.95,
- f. Point Cabrillo Drive, CR 564, M.P. 0.00 to M.P. 2.92,
- g. Comptche Ukiah Road, CR 223, M.P. 10.00 to M.P. 24.00; and

WHEREAS, on January 8, 2019, the Board of Supervisors accepted the Director of Transportation's Report, which included a 20-Year Maintenance Plan for the County's Road System utilizing Road Maintenance and Rehabilitation Account (RMRA) funds; and

WHEREAS, the estimated \$3,000,000 cost of the 2026 Corrective/Preventative Maintenance Project on Various County Maintained Roads is anticipated to be paid for in full using available Road Maintenance and Rehabilitation Account (RMRA) funds; and

WHEREAS, this project will be completed to provide the maintenance required to improve and extend the usefulness of our roads; and

WHEREAS, funding to accommodate construction costs is available in Budget Unit 3041 for Fiscal Year (FY) 2025/26 and FY 2026/27; and

WHEREAS, construction costs, including bid additives, are estimated to amount to between \$2,000,000 to \$3,000,000, and will be performed depending on the availability of additional funds; and

WHEREAS, under Section 20395 of the California Public Contract Code, the Board of Supervisors may authorize the Director of Transportation to execute contract change orders subject to certain cost limitations; and

WHEREAS, by Resolution 24-101 (June 25, 2024), the Board of Supervisors authorized the Director of Transportation to order changes or additions to the work being performed under construction contracts administered by DOT, subject to the limits provided in Public Contract Code Section 20395; and

WHEREAS, pursuant to said Resolution and said Section, the Director of Transportation is authorized to execute changes to any DOT contract that exceeds \$250,000 for the extra cost for any change or addition to the work by up to \$25,000, plus 5% of the amount of the original contract costs in excess of \$250,000, with the proviso that no change or alteration shall exceed \$210,000; and

WHEREAS, DOT recommends and requests authorization to proceed with the

advertisement and award of DOT Contract No. 260010 to construct the 2026 Corrective/Preventative Maintenance Project.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby:

1. Authorizes the Director of Transportation to sign the Notice to Bidders inviting bids for DOT Contract No. 260010 for the 2026 Corrective/Preventative Maintenance Project on Various County Maintained Roads in the Caspar area; and
2. Authorizes and directs the Director of Transportation to award DOT Contract No. 260010 for a sum not to exceed \$3,000,000, depending on available funds, upon confirmation of an appropriate low responsive bidder and acceptable contract documents by County Counsel and Risk Management, and to report the results to the Mendocino County Board of Supervisors through the applicable Chief Executive Officer's Report.

The foregoing Resolution introduced by Supervisor Haschak, seconded by Supervisor Mulheren, and carried this 19<sup>th</sup> day of May, 2026, by the following vote:
