

**FIRST AMENDMENT TO COUNTY OF MENDOCINO
AGREEMENT NO. BOS 23-189**

This first Amendment to Agreement No. BOS 23-189 is entered into by and between the **COUNTY OF MENDOCINO**, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and **YAO ENGINEERING, INC.**, hereinafter referred to as "CONTRACTOR," on the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. BOS 23-189 was entered into on November 7, 2023; and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this first Amendment will become part of the Agreement and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to extend the termination date from October 31, 2025, to October 31, 2027; and

WHEREAS, it is the desire of the COUNTY and CONTRACTOR to keep the compensation payable amount of \$58,790 unchanged.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the Agreement is hereby extended from October 31, 2025, to October 31, 2027.

All other terms and conditions of the Agreement shall remain in full force and effect.
