**THIRD AMENDMENT TO COUNTY OF MENDOCINO
AGREEMENT NO. BOS-22-247**

This third Amendment to Agreement No. BOS-22-247 is entered into by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and the Superior Court of California, County of Mendocino, hereinafter referred to as "COURT," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. BOS-22-247 was entered into on October 4, 2022 (the "Initial Agreement"); and

WHEREAS, First Amendment No. BOS-22-247-A1 was entered into on June 20, 2023 (the "First Amendment"); and

WHEREAS, Second Amendment No. BOS-22-247-A2 was entered into on June 25, 2024 (the "Second Amendment"); and

WHEREAS, the Initial Agreement, First Amendment, and Second Amendment are referred to as "the Agreement"; and

WHEREAS, upon execution of this document by COUNTY and COURT, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and COURT to extend the termination date set out in the Agreement, from June 30, 2025, to June 30, 2027; and

WHEREAS, it is the desire of COUNTY and COURT to amend the terms of the Agreement to allow for the parties to agree to an extension of more than one year.

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the Agreement is hereby extended from June 30, 2025, to June 30, 2027.
2. Paragraph 1.i. "Term/Option to Extend", set out in the Agreement is amended to read as follows:

Term/Option to Extend. This MOU is effective from October 4, 2022 (Effective

Date), and will continue in force and effect through June 30, 2027, provided, however, that the term of this MOU may be extended by mutual agreement of the parties in accordance with the terms of this MOU. In the event the Court moves to a new courthouse in Ukiah before the expiration of this MOU, Court, Sheriff and County shall execute a new MOU to be effective upon the Court's relocation to the new courthouse. To ensure that a new agreement is in place at the time the Court relocates to the new courthouse, the parties agree to begin negotiating the terms of a new agreement no later than June 30, 2026. In the event that a new agreement has not been created by the time a new courthouse is built, the parties shall follow the terms of this MOU to the extent possible. ii. Termination. In the event either party desires to terminate this MOU prior to the end of its term, that party shall provide written notice to the other party at least six months prior to the proposed date of termination. The MOU may only be terminated at the end of a fiscal year (June 30).

All other terms and conditions of the Agreement shall remain in full force and effect.
