**FOURTH AMENDMENT TO COUNTY OF MENDOCINO
AGREEMENT NO. HR-22-04**

This Fourth Amendment to Agreement No. HR-22-04 is entered into by and between the **COUNTY OF MENDOCINO**, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and LIEBERT CASSIDY WHITMORE, hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. HR-22-04 was entered into on January 18, 2022 (the "Initial Agreement"); and

WHEREAS, First Amendment to Agreement No. HR-22-04 was entered into on December 8, 2022 (the "First Amendment") increasing the total amount by \$3,520 for a new total of \$6,780; and

WHEREAS, Second Amendment to Agreement No. HR-22-04 was entered into on December 27, 2023 (the "Second Amendment") increasing the total amount by \$3,700 for a new total of \$10,570 and

WHEREAS, Third Amendment to Agreement No. HR-22-04 was entered into on January 15, 2025 (the "Third Amendment") increasing the total amount by \$3,700 for a new total of \$14,270 and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this Fourth Amendment will become part of the Agreement and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to extend the termination date from December 31, 2025 to December 31, 2026; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to increase the total amount payable by \$3,700 from \$14,270 to \$17,970; and

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the Agreement is hereby extended from December 31, 2025 to December 31, 2026.
2. The total contracted amount set out in the Agreement is hereby increased by

\$3,700 from \$14,270 to \$17,970;

All other terms and conditions of the Agreement shall remain in full force and effect.

Enclosed is the invoice for the consortium year. You'll note that the invoice covers the consortium as well as any Liebert Library subscription your organization may have.


The annual workshop schedule will be sent out shortly.
