Transportation Funding - Senate Bill 1 (SB1) Recap from January 8, 2019 (Twenty Year Plan)

- Funded by SB-1 Road Maintenance & Rehabilitation Account (RMRA) funds
- ~\$115 million over those 20 years
- ~\$574 million in unmet paving needs over the next 10 years
- Receive ~\$5.5 million annually – treats ~15-25 miles, depending on road condition
- Treats 357 miles of the ~675 miles of surfaced roads
- 90% of “surfaced” County Roads - years of chip seal, NOT asphalt concrete (AC) pavement
- Currently in Year 8 of the Plan

Solid Waste, Organics Diversion & Recycling



- Mendocino County Solid Waste Division oversees:
 - Franchise agreements for curbside collection in 4 County franchise areas
 - Operations agreements for 8 transfer stations
 - Implementation of state regulations related to solid waste disposal, recycling and organics
 - County closed landfills
- Mendocino Solid Waste Management Authority (MSWMA) – Administered by City of Ukiah - oversees:
 - Household hazardous waste collection - Wednesday 9 AM to 1 PM at 3200 Taylor Drive, Ukiah, and select Saturdays at various locations around the County
 - Illegal dumping cleanup – dump sites throughout the county can be reported to City of Ukiah Public Works Department, Attn: Seth Strader (707) 467-5719

Closed Landfills: Caspar, Laytonville, South Coast

- **Solid Waste Division Responsibilities (California Code of Regulations Title 27 compliance):**
 - **Closure** – South Coast Landfill planned for final closure Summer 2026
 - **Post-closure maintenance / corrective action plans** – prepare and periodically update plans (every 5 years), Laytonville Landfill planned for corrective action project 2027 or 2028
 - **Maintenance of control systems** – routine inspections, general site maintenance and repair, stormwater management and erosion control, leachate collection and disposal, gas and water well maintenance, vegetation management
 - **Environmental monitoring** – quarterly groundwater and surface water sampling, quarterly/monthly landfill gas monitoring, annual leachate sampling
 - **Reporting** – Quarterly/annual reporting to NCRWQCB, annual financial assurance reporting to CalRecycle

Water Agency

Current Water Agency Programs/Projects:

- National Pollutant Discharge Elimination System (NPDES) stormwater permit compliance
- Mill Creek Ponds Invasive Mussel Prevention Plan implementation
- Sustainable Groundwater Management Act (SGMA) implementation through participation in Ukiah Valley Basin Groundwater Sustainability Agency (UVBGSA)
- California Statewide Groundwater Elevation Monitoring (CASGEM) implementation
- Drought Resilience Plan (DRP) implementation & monitoring

Airports – Cost to County is Low

- County general fund match of 2.5% to 5%
- FAA AIP grants – 95%
- California Division of Aeronautics grants 2.5%
- Grants in the amount of \$6.65 million since 2005



- MCDOT oversees safe airport operations and general management
- Work with the Federal Aviation Administration (FAA) and the California Dept. of Transportation Division of Aeronautics to fund capital improvement projects and improve airport safety
- Work with our aviation consultants, Mead and Hunt, on planning and engineering projects
- Coordinate with local, State, and Federal agencies for and during emergencies.

Land Improvement – Permit Authority in the Public Right-of-Way

- The California Vehicle Code and Streets and Highways Code give local governments the authority to maintain safe passage for the traveling public. MCDOT must consider all uses in the public roadways in the public interest, both present and future. The 2008 Board of Supervisors adopted Road and Development Standards, thus our permit conditions on property owners and businesses in the public right-of-way also consider the future needs.



Potential Local Sales Tax for Roads

Potential Local Sales Tax for Roads

- County may pursue sales tax in unincorporated area only – No overlap with incorporated areas
- 1 cent sales tax could provide approximately \$6 million annually IF dedicated for Roads thus receiving State “Self-Help County” share (\$5.5 million without “Self-Help County” share).
- New \$5.5 million budget could provide about 20 miles per year – ability to treat all 317 miles not in the RMRA 20-Year Plan in 18 years:
 - 5 to 9 miles paving per year – sharp curves - steep grade
 - 9 to 13 miles In place recycle w/ chip seal (double layer)
 - 43-67 miles chip seal (double layer)
 - \$1/2 million to restore maintenance crew staff by 7 to 9 positions




Recent Poll Shows Voters are Concerned about the Condition of County Roads

- Nearly three-quarters (73%) feel the County has an appreciable need for funding for roads (only 70% in 2002)
- Initial support for a measure reached two-thirds (66% total yes, with 39% definitely yes) (average in the 60's)
- The top investment priorities are:
 - durable repair of potholes
 - prolonging the life of roads
 - repairing major roads

The Potential Ballot Measure

To maintain and improve deteriorating roads; permanently resurface potholes on local roads; all in the unincorporated areas of the County only, shall the Mendocino County measure establishing a one-cent sales tax in those areas for 18 years, providing approximately \$5.5 million annually, with public disclosure of funds, independent annual audits, and all funds legally required to be spent locally only on Mendocino County roads, be adopted?



How Should the Tax be Used?

78% believe it is Extremely or Very Important that the tax be used for permanently fixing potholes (not just patches)

78% think it is important to use the tax revenues for repairing distressed roads to prevent further deterioration

74% believe tax should be used to prolong the life of existing roads

70% of voters support using funds for the busiest roads that people drive on every day

Traffic congestion, bike trails, road widening low priorities

General or Specific Tax?



General Tax

Requires majority approval
(50% + 1)

Potential for lower voter turnout
No benefit from possible
incentives



Specific Tax

Requires 2/3 approval (66.7% + 1)
Must be used for specific purpose
Potential for “self-help” incentives

Current Taxes per California Department of Tax and Fee Administration

Local Agency	Current Tax Rate
Mendocino County	7.875%
City of Fort Bragg	9.25%
City of Point Arena	9.25%
City of Ukiah	8.875%
City of Willits	9.125%

If Mendocino County wants to stay at or under city tax rates, then the County has 1.375% capacity
