I am a Senior Program Manager with the Special Projects Team in the Mendocino County Department of Social Services. My team and I are responsible for the management and oversight of several large housing projects as follows: 1) Front Door for Families. This project provides housing guidance, housing problem-solving, and access to direct financial assistance for households with children experiencing or at-risk of homelessness. The project encompasses and manages the Bringing Families Home program - a housing program specifically targeted to families involved with child welfare services and experiencing housing instability. The program also incorporates CalWorks Housing Support Program, Housing Navigation and Maintenance Program (targeted to former foster youth), and the Family Homelessness Challenge Grant. 2) Project Homekey - Live Oak Apartments. This apartment complex provides transitional and permanent housing to households experiencing homelessness. One of the target populations for this project are households with child welfare involvement. 3) Mendocino County Homeless Services Continuum of Care. My team and I facilitate and serve as the administrative lead for our local Continuum of Care - a HUD-required collaborative entity responsible for managing certain federal and state housing resources allocated to Mendocino County.
