**THIRD AMENDMENT TO COUNTY OF MENDOCINO  
AGREEMENT NO. BOS-24-062**

This Third Amendment to Agreement No. BOS-24-062 is entered into by and between the **COUNTY OF MENDOCINO**, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and **DFM Garage, Inc. DBA DFM Auto Repair**, hereinafter referred to as "CONTRACTOR," the date this Amendment is fully executed by all parties.

WHEREAS, Agreement No. BOS-24-062 was entered into on May 7, 2024 (the "Initial Agreement"); and

WHEREAS, First Amendment to Agreement No. BOS-24-062 was entered into on June 25, 2024 (the "First Amendment") extending the term from June 30, 2024 to June 30, 2025, and increasing the total amount from \$50,000 to \$200,000; and

WHEREAS, Second Amendment to Agreement No. BOS-24-062 was entered into on July 8, 2025 (the "Second Amendment") extending the term from June 30, 2025 to June 30, 2026, and increasing the total amount from \$200,000 to \$325,000; and

WHEREAS, the Initial Agreement, First Amendment, and Second Amendment are referred to as the Agreement; and

WHEREAS, upon execution of this document by COUNTY and CONTRACTOR, this third Amendment will become part of the Agreement and shall be incorporated therein; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to extend the termination date from June 30, 2026 to May 6, 2027; and

WHEREAS, it is the desire of COUNTY and CONTRACTOR to increase the total amount payable by \$175,000 from \$325,000 to \$500,000; and

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the Agreement is hereby extended from June 30, 2026 to May 6, 2027.
2. The total contracted amount set out in the Agreement is hereby increased by \$175,000 from \$325,000 to \$500,000.

All other terms and conditions of the Agreement shall remain in full force and effect.
